Our commercial disputes lawyers have the skills and experience to support clients in navigating technically and factually complex and high-value disputes.

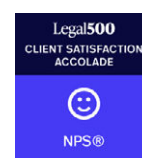
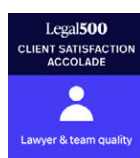
